DATE OF FINAL PASSAGE DEC 15 2006

WHEREAS, on February 8, 1977, Ms. Barbara Ventura began working for former Councilmember Bill Lowery of Council District 3 and was the sole council representative in the office; became one of two council representatives for former Councilmember Dick Murphy of Council District 7 in 1980; and continued in this role for former Councilmember Bill Cleator in 1987; and

WHEREAS, on February 7, 1987, former Deputy Mayor Gloria McColl appointed Ms. Ventura "Confidential Secretary" to the 10th floor, a position now known as "Director of Council Administration"; and

WHEREAS, Ms. Ventura is an integral part of the daily operations of the City Council providing a wealth of knowledge, an understanding of protocol that alleviates transitions between councilmembers, and a background in nursing she exercises to the benefit of all City Council staffers; and

WHEREAS, over the past 26 years of service with the City of San Diego, Ms. Ventura has worked with six mayors, seven city managers, six police chiefs, seven fire chiefs, and 46 councilmembers; NOW, THEREFORE;

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does offer appreciation and hereby proclaims December 5, 2006, to be "BARBARA VENTURA DAY" in the City of San Diego.
