A RESOLUTION APPROVING PLANS AND SPECIFICATIONS; AUTHORIZING THE MAYOR TO ADVERTISE AND AWARD FOR THE MIRAMAR ROAD TRUNK SEWER

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the plans and specifications for the construction of the Miramar Road Trunk Sewer [Project], filed in the office of the City Clerk as Document No. W.O. 177041, are approved.

2. That, after advertising for bids in accordance with law, the Mayor is authorized to award the Project contract to the lowest responsible and reliable bidder in an amount not to exceed \$3,954,777, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$3,790,002 from Sewer Fund 41506, CIP No. 46-195.8, Miramar Road Trunk Sewer and an expenditure of an amount not to exceed \$164,775 from Sewer Fund 41506, CIP No. 46-193.0, Annual Allocation – Muni Pooled Contingency, for the purpose of providing funds for project contingency, contingent upon the approval of the Fiscal Year 2007 Capital Improvement Program and Appropriation Ordinance, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds are, or will be, on deposit with the City Treasurer.

6. That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
