A RESOLUTION AUTHORIZING EXECUTION OF AN AGREEMENT FOR A UNITED STATES BUREAU OF RECLAMATION WATER CONSERVATION FIELD SERVICES PROGRAM GRANT; AND TAKING RELATED ACTIONS

WHEREAS, in December of 2005 the United States Bureau of Reclamation [BOR] solicited proposals for grant funding under BOR's Water Conservation Field Services Program (Southern California Area) for projects that make more efficient use of existing water supplies; and

WHEREAS, the City of San Diego's Water Department [Department] submitted an application for grant funding for the Mapping Interface Enhancements to Urban Vegetation Satellite Imagery project, which will make programming improvements to the ArcGIS mapping function [Project], resulting in increased efficiency in conducting landscape audits and ultimately leading to greater water conservation; and

WHEREAS, the total Project cost is estimated to be \$28,302, and the Department was notified in May of 2006 that the Project was selected by BOR for grant funding in the amount of \$14, 151 [Grant]; and

WHEREAS, the Grant will require a fifty percent (50%) match which the City will provide in the form of in-kind staff charges of \$8,302 and cash of \$5,849 budgeted within the Department's Customer Support Division's FY 07 operating budget; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor or his designee is authorized to apply to and execute an agreement with BOR for the Grant for the Project in the form on file in the office of the City Clerk as Document No. RR-302162, together with any reasonably necessary modifications or amendments thereto which do not increase agreement scope or cost and which the Mayor or his designee shall deem necessary from time to time in order to carry out the purposes and intent of the agreement.
- 2. That the Mayor or his designee is authorized to take all necessary actions to secure the Grant.
- 3. That the City Auditor and Comptroller is authorized to accept, appropriate, and expend the funds if the Grant is secured.
- 4. That this activity is not subject to the California Environmental Quality Act

  [CEQA] pursuant to CEQA Guidelines section 15060(c)(2) because it will not
