
BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the City Auditor and Comptroller is hereby authorized to transfer \$200,000 from CIP-52-274.0, Balboa Avenue Corridor Improvements Project, Fund 38978, State Cooperative Agreement Fund to the special interest-bearing Fund 389781; and

2. That the City Auditor and Comptroller is authorized to appropriate and expend the amount of \$200,000 from Fund 389781 for the managing and maintaining of the Balboa Avenue Corridor Improvements Project by the City's Park and Recreation Department, contingent upon the Auditor and Comptroller certifying funds are available.
