
A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ACCEPTANCE OF GRANT FOR THE CITY HEIGHTS SWIMMING POOL PROGRAMS.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his representative is authorized to apply to Price Charities, a non profit corporation under 501 (c) (3), for \$42,600 grant funds for the City Heights Swimming Pool Programs [Project].
2. That the Mayor or his representative is authorized to take all necessary actions to secure funding from Price Charities for the Project.
3. That the City Auditor and Comptroller is authorized to accept, appropriate and expend funds if the Grant is secured.
4. That the City Auditor and Comptroller is authorized to establish a special interest-bearing fund for the Grant.

BE IT FURTHER RESOLVED, that this activity is exempt from CEQA pursuant to section 15061(B)(3), as defined by the State CEQA Guidelines.
