A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO ACCEPT AN FAA AIRPORT DEVELOPMENT GRANT IN THE AMOUNT OF \$1,111,500 FOR BROWN FIELD AIRPORT RUNWAY ELECTRICAL UPGRADE; AND AUTHORIZING THE TRANSFER OF \$155,601.55 FROM THE AIRPORT ANNUAL ALLOCATION FUND 310010 TO THE CIP 31.300.0 FUND AS THE CITY 5% GRANT MATCHING FUNDS: AND AUTHORIZING THE TRANSFER AND EXPENDITURES OF \$1,267,101.66 FOR THE BROWN FIELD ELECTRICAL UPGRADE PROJECT; AND AUTHORIZING AN INCREASE IN THE CIP BUDGET OF \$1,267,101.55: AND ACCEPT BID AND AWARD DESIGN CONTRACT TO HNTB FOR 347,064; AND ACCEPT BID AND AWARD CONSTRUCTION CONTRACT TO NOVA ELECTRIC INC. IN THE AMOUNT OF 964,240 DOLLARS.

WHEREAS, the City's Airports Division has proposed improvements to the runway lighting electrical system at Brown Field Airport with a general upgrade, Phase 2, which would be designed in accordance with Federal and State standards for airports, will increase safety and operation efficiency at Brown Field Airport; and

WHEREAS, the Federal Aviation Administration [FAA] made a Grant Offer in the amount of \$1,111,500 which had to be accepted no later than August 30, 2006 or the offer would have been voided and which offer has been extended by agreement with the FAA; and

WHEREAS, the electrical upgrade will eliminate the wet weather generalized failures of the system and associated repair bills; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to accept the Federal Aviation Administration Grant Offer in the amount of \$1,111,500 dollars.

- 2 BE IT FURTHER RESOLVED THAT the transfer of \$151,601.55 from the Airport Fund 310010, Annual Allocation Fund, to CIP 31-300.0 as the 5% City matching funds for the project is authorized.
- 3. BE IT FURTHER RESOLVED THAT the Mayor, or his designee, is authorized to enter into an agreement for the design of the electrical upgrade, phase 2, with the HNTB Corporation, as the lowest responsible bidder, in an amount not to exceed \$347,064 dollars.
- 4. BE IT FURTHER RESOLVED THAT the Mayor, or his designee, is authorized to enter into an agreement for the construction of the upgrade with Nova Electric Inc., as the lowest responsible bidder, in an amount not to exceed 964,240 dollars.
- 5. BE IT FURTHER RESOLVED THAT the Auditor and Comptroller is authorized to release \$1,267,101.55 from CIP 31-300.0 for the Brown Field runway electrical upgrade, Phase 2.
- 6. BE IT FURTHER RESOLVED THAT the Fiscal Year 2007 CIP Budget is increased in the amount of \$1,267,101.55 dollars.
