A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO ACCEPT AN FAA AIRPORT DEVELOPMENT GRANT IN THE AMOUNT OF \$427,500 DOLLARS FOR A MONTGOMERY FIELD AIRPORT BLAST PAD; AND AUTHORIZING THE TRANSFER OF \$7,711.05 FROM THE AIRPORT FUND TO THE CIP 31.313.1 FUND AS CITY 5% GRANT MATCHING FUNDS; AND AUTHORIZING THE TRANSFER AND EXPENDITURE OF \$435,211.05 FOR THE MONTGOMERY FIELD BLAST PAD PROJECT; AND AUTHORIZING AN INCREASE IN THE CIP BUDGET OF \$435,211.05; AND ACCEPT THE BID AND AWARD CONTRACT TO DALEY CORPORATION FOR \$322,071

WHEREAS, the City's Airports Division has proposed improvements to Montgomery
Airport Field Runway 28L with a Blast Pad which would be designed in accordance with Federal
and State standards for airports and will increase safety and operational efficiency at
Montgomery Field Airport; and

WHEREAS, the Federal Aviation Administration [FAA] made a Grant Offer in the amount of \$427,500 which had to be accepted no later than August 30, 2006, or the offer would have been voided, which has been extended by agreement with the FAA; and

WHEREAS, the Blast Pad will eliminate the loose rock surface of the runway safety area, thereby reducing the need for staff to clear foreign object debris from the approach end of runway 28L; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor is authorized to accept the Federal Aviation Administration Grant Offer in the amount of \$427,500.

- 2. BE IT FURTHER RESOLVED, that the transfer of \$7,711.05 from the Airport Fund 310010, Annual Allocation Fund, to CIP 31-313.1 as the 5% City matching funds for the project is authorized.
- 3. BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to enter into an agreement for the construction of the Blast Pad with the Daley Corporation, as the lowest responsible bidder, in an amount not to exceed \$322,071.
- 4. BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to expend \$435,211.05 from CIP 31-313.1 for the Montgomery Field Blast Pad; and
- 5. BE IT FURTHER RESOLVED, that the Fiscal Year 2007 CIP Budget is increased in the amount of \$435,211.05
