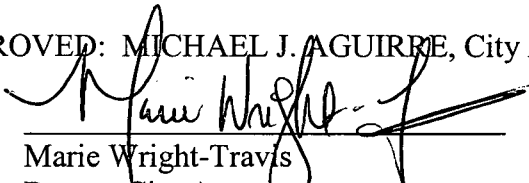

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is hereby authorized, contingent upon the Auditor and Comptroller first certifying that the money that the money is available, to pay the total sum of \$ 270,782 for the release and the settlement of each and every claim against the City of San Diego, its agents and employees, submitted in the contractual claims resulting from the delay and extra work costs arising out of the work performed by METRO-BUILDERS ENGINEERING GROUP on the contracts for construction of Mid-City Transit Facilities at El Cajon Boulevard and University Avenue.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to issue one check in the amount of \$ 270,782, made payable to METRO-BUILDERS ENGINEERING GROUP, in full settlement of all claims.
