A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A ONE-YEAR EXTENSION OF THE NORTH PARK REDEVELOPMENT PROJECT AREA COMMITTEE AND DIRECTING THE REDEVELOPMENT AGENCY STAFF TO NOTICE AND CONDUCT THE ANNUAL PROJECT AREA COMMITTEE ELECTION IN 2007.

WHEREAS, California Community Redevelopment Law allows the Project Area Committee to function for a three-year period after the adoption of the Redevelopment Plan, and for one year extensions thereafter by approval of the City Council of the City of San Diego ("Council"); and

WHEREAS, on October 16, 1990, the Council approved Resolution No. R-276720 to adopt the Formation Procedures ("Procedures") for the North Park Redevelopment Project Area Committee ("PAC"); and

WHEREAS, on December 8, 2003, the Council approved Resolution No. R-298703 to amend the Procedures for the North Park PAC; and

WHEREAS, the amended Procedures require Council authorization to extend the PAC an additional year and to notice and conduct the PAC Election; NOW, THEREFORE,


BE IT RESOLVED, that the City Council of the City of San Diego as follows:

1. That the North Park PAC is extended for one year.
2. That the staff of the Redevelopment Agency of the City of San Diego is directed

to notice and conduct the annual PAC Election in 2007.

3. That this activity is not a "project" and is therefore not subject to CEQA pursuant to State CEQA Guidelines Section 15060 (c)(3).
