WHEREAS, the amended Procedures require Council authorization to extend the PAC an additional year and to notice and conduct the PAC Election; NOW, THEREFORE,

BE IT RESOLVED, that the City Council of the City of San Diego as follows:

- 1. That the North Park PAC is extended for one year.
- 2. That the staff of the Redevelopment Agency of the City of San Diego is directed to notice and conduct the annual PAC Election in 2007.
