RESOLUTION ADOPTING A CONFLICT OF INTEREST CODE FOR THE OFFICE OF SPECIAL EVENTS

WHEREAS, Government Code sections 87300 and 87302 require local agencies to adopt conflict of interest codes designating positions that involve the making or participation in making of decisions which may foreseeably have a material effect on financial interests, and for each position, the financial interests which are reportable; and

WHEREAS, in compliance with Government Code section 87306.5, the City is in the midst of a City-wide biennial review of all conflict of interest codes for which the City Council serves as code reviewing body;

WHEREAS, the Office of Special Events is a restructured office reporting to the Neighborhood and Customer Services Department; and

WHEREAS, the Office of Special Events now seeks to enact a new conflict of interest code, which includes positions that were moved during restructuring and lists required filing categories for each position;

WHEREAS, the Mayor and City Attorney recommend that a Conflict of Interest Code be adopted for the Office of Special Events; and

WHEREAS, the City Council concurs in this recommendation; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that a Conflict of Interest Code for the Office of Special Events is hereby adopted, consisting of standard language embodied in title 2, section 18730 of the California Code of Regulations, and any amendments to

that regulation duly adopted by the Fair Political Practices Commission, with Appendix A showing designated positions and their duties, and Appendix B showing the disclosure categories.

BE IT FURTHER RESOLVED, that a copy of Appendix A and Appendix B to the Conflict of Interest Code for the Office of Special Events as adopted be placed on file in the Office of the City Clerk as Document No. RR-302208.

BE IT FURTHER RESOLVED, that the persons whose positions are designated in the new Conflict of Interest Code for the Office of Special Events shall file their statements of economic interest with the City Clerk.

BE IT FURTHER RESOLVED, that the statements of economic interest filed by designated persons be retained by the Office of the City Clerk and be made available for public inspection and reproduction.

BE IT FURTHER RESOLVED, that the Conflict of Interest Code for the Office of Special Events becomes effective upon the date of final passage of this resolution.

APPENDIX A – DESIGNATED POSITIONS

Position	<u>Duties</u>		
Director of Special Events Special Events Administrator	Generate and negotiate events which produce revenues for the City; provide specialized expertise for major City-sponsored events; monitor the City wide permitting process set forth in the Special Events Ordinance, including applications, departmental routing, permit approvals, coordinate with other agencies; and manage the City Store.		1
Consultants	Performs consultant services for the Office of Special Events. See Appendix B.		2

APPENDIX B - DISCLOSURE CATEGORIES

CATEGORY 1:

- a. Investments and business positions in any firm or business entity that supplies goods or services to the City, that is tenant of the City, that is an adverse party to the City in a legal proceeding, or is granted authority by the City to use City facilities.
- b. Interests in real property owned or used by any person or business entity that supplies goods or services to the City, that is a tenant of the City, that is an adverse party to the City in a legal proceeding, or is granted authority by the City to use City facilities.
- c. Income and gifts from any person or business entity that supplies goods or services to the City, that is a tenant of the City, that is an adverse party to the City in a legal proceeding, or is granted authority by the City to use City facilities.

CATEGORY 2:

Consultants shall be included in the list of designated employees and shall disclose pursuant to the broadest category in the code subject to the following limitation:

The department director, assistant department director, program or projects managers, or supervisors may determine in writing that a particular consultant, although a "designated position" is hired to perform a range of duties that is limited in scope and thus is not required to fully comply with the disclosure requirements described in this section. Such written determination shall include a description of the consultant's duties, and based upon that description, a statement of the extent of disclosure requirements. The department director's assistant director's program or project manager's or supervisor's determination is a public record and shall be retained for public inspection in the same manner and location as the Conflict of Interest Code.
