WHEREAS, the City Clerk has proposed changes to the code for the Land Use Boards and Commissions to add commissions which were already required to file Statements of Economic Interests but were not listed in the code; NOW THEREFORE,

BE IT RESOLVED, that the changes to Appendix A of the Conflict of Interest Code for the Land Use Boards and Commissions are hereby approved and incorporated into its Conflict of Interest Code.

BE IT FURTHER RESOLVED, that revised Appendix A to the Conflict of Interest Code for the Land Use Boards and Commissions be placed on file in the Office of the City Clerk as Document No. RR-302216.

BE IT FURTHER RESOLVED, that the revised Conflict of Interest Code for the Land Use Boards and Commissions shall become effective on the date of final passage.
