A RESOLUTION DECLARING THE RESULTS OF THE  
SPECIAL MUNICIPAL ELECTION HELD IN THE CITY OF  
SAN DIEGO ON NOVEMBER 7, 2006.

WHEREAS, a special municipal election was held in the City of San Diego on Tuesday, November 7, 2006, pursuant to the provisions of Ordinance No. 19473 (New Series), adopted July 17, 2006, for the purpose of submitting to the qualified voters of the City of San Diego two propositions, described as follows:

- (1) One proposition regarding whether or not the Charter should be amended to require voter approval for any increases in retirement system benefits for public employees (Proposition B); and
- (2) One proposition regarding whether or not the Charter should be amended to allow the City to contract services traditionally performed by City civil service employees if determined to be more economical and efficient while maintaining the quality of services and protecting the public interest (Proposition C); and

WHEREAS, these propositions read as follows:

<b>PROPOSITION B. AMENDS THE CITY CHARTER TO CHANGE THE APPROVAL PROCESS FOR INCREASES IN CITY EMPLOYEES' RETIREMENT SYSTEM BENEFITS.</b> Shall the Charter be amended to require voter approval for any increases in retirement system benefits for public employees?	YES

<b>PROPOSITION C. AMENDS THE CITY CHARTER TO ALLOW FOR CONTRACTING OUT OF CITY SERVICES.</b> Shall the Charter be amended to allow the City to contract services traditionally performed by City civil service employees if determined to be more economical and efficient while maintaining the quality of services and protecting the public interest? WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the special municipal election, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of this election has been completed and the City Clerk has certified the results to the City Council;

WHEREAS, declaring the results of the election as certified by the Registrar of Voters and the City Clerk is a ministerial act required by California Elections Code section 10263 and, therefore, is not subject to veto by the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council finds and determines, pursuant to the provisions of Section 27.0411 of the San Diego Municipal Code, as follows:

1. The whole number of votes cast in the City was 333,994.
2. The number of votes cast in the City for and against each of the two propositions which appeared on the ballot as Propositions B and C, and the total number of votes cast upon those propositions, are as follows:

PROPOSITION B

For	214,788
Against	92,302
TOTAL	307,090

Proposition B received the affirmative vote of a majority of the qualified voters voting on such proposition and is hereby declared to have been approved.

PROPOSITION C


For	185,688
Against	121,906
TOTAL	307,594

Proposition C received the affirmative vote of a majority of the qualified voters voting on such proposition and is hereby declared to have been approved.

3. The number of votes cast for and against the proposition is recorded in the Election Returns Book, which book is a part of the records of this Council.

4. The City Clerk shall make public the results of the canvass of the special municipal election by publication of a copy of this resolution.
