BE IT RESOLVED, by the Council of the City of San Diego, that Council President Scott Peters is hereby appointed jointly by the Mayor and City Council to serve as representative, alternate, or liaison to the organizations listed below for the period commencing January 1, 2007, through December 31, 2007.
