BE IT RESOLVED, by the Council of the City of San Diego, that Councilmember Toni Atkins is hereby appointed jointly by the Mayor and City Council to serve as representative, alternate, or liaison to the organizations listed below for the period commencing January 1, 2007, through December 31, 2007.
