A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE IMPLEMENTATION OF A FINANCIAL TRAINING PROGRAM FOR CITY COUNCIL MEMBERS AND AUTHORIZING THE OFFICE OF THE INDEPENDENT BUDGET ANALYST WITH THE ASSISTANCE OF THE CITY ATTORNEY AND CHIEF FINANCIAL OFFICER TO DEVELOP A COMPREHENSIVE PROGRAM AS DESCRIBED IN THE REPORT OF THE INDEPENDENT BUDGET ANALYST

WHEREAS, the Report of the Audit Committee of the City of San Diego [Kroll Report], on file with the City Clerk. RR-302243, was presented to the City Council on August, 8, 2006; and

WHEREAS, the Kroll Report recommended extensive remedial measures to implement stronger controls and practices in financial reporting, management and governance, not including financial training for elected officials; and

WHEREAS, on September 6, 2006, the City Council accepted in principle the recommendations of the Kroll Report and added the further recommendation that City Council Members and their staff undergo financial training to aid them in carrying out their oversight responsibilities; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

Section 1 That the Report of the Independent Budget Analyst [IBA Report] is accepted.

Section 2 That the Independent Budget Analyst, with the assistance of the City Attorney and the Chief Financial Officer, develop and implement a financial training program for City Council Members, as outlined in the IBA Report.

Section 3 That the City Attorney is directed to prepare all appropriate ordinances or resolutions to implement the financial training program.


