AN ORDINANCE AUTHORIZING EXECUTION OF A FOURTH AMENDMENT TO CONSULTANT AGREEMENT WITH ESTRADA LAND PLANNING, INC. FOR THE NORTH CHOLLAS COMMUNITY PARK – PHASE 1C PROJECT.
