AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF A FIRST AMENDMENT TO THE AGREEMENT WITH URS CORPORATION FOR THE MIRA SORRENTO PLACE – SCRANTON ROAD TO VISTA SORRENTO PARKWAY PROJECT

BE IT ORDAINED, by the Council of the City of San Diego as follows:

Section 1. That the Mayor, or his designee, be and he is hereby authorized and empowered to execute, for and on behalf of said City, a first amendment to the agreement with URS Corporation for additional professional environmental services, under the terms and conditions set forth in the document on file in the Office of the City Clerk as Document No. OO- 19583, for CIP 52-676.0, Mira Sorrento Place – Scranton Road to Vista Sorrento Parkway, in the amount of \$63,900, Fund 79006, Mira Mesa Facilities Benefit Assessment (FBA).

Section. 2. That the Auditor and Comptroller is authorized to expend an amount not to exceed \$63,900 from CIP 52-676.0, Mira Sorrento Place – Scranton Road to Vista Sorrento Parkway, Fund 79006, Mira Mesa Facilities Benefit Assessment (FBA) for the purpose of executing the aforementioned first amendment, contingent upon the Auditor and Controller first certifying that the funds are or will be available in the City Treasury.

Section 3. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 4. A full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
