AN ORDINANCE AUTHORIZING ANGLE PARKING ON MAIN STREET BETWEEN CESAR CHAVEZ PARKWAY AND SIGSBEE STREET

WHEREAS, the businesses and residents of the City of San Diego with real property on Main Street between Cesar Chavez Parkway and Sigsbee Street submitted a petition requesting angle parking on said street;

AND WHEREAS, the City Transportation Engineering Division of the Engineering and Capital Projects Department has reviewed this petition and has determined, using accepted traffic engineering principles, that angle parking can be installed with an adequate margin of safety;

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. Pursuant to the authority conferred by and in accordance with the provisions of California Vehicle Code section 22503 and San Diego Municipal Code section 86.03, the creation of an angle parking zone on Main Street between Cesar Chavez Parkway and Sigsbee Street is hereby authorized.

That the installation of the necessary signs or markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs or markings, or 30 days after the final passage of this ordinance, whichever comes later.

Section 2. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.

Section 4. That this action is exempt from the California Environmental Quality Act pursuant to CEQA Guidelines Section 15301 because this action is the minor alteration of an existing facility with a negligible expansion beyond the existing use
