AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A MASTER LEASE AGREEMENT FOR THE PURPOSE OF FINANCING THE ACQUISITION OF THE ENTERPRISE RESOURCE PLANNING SYSTEM IN A PRINCIPAL AMOUNT NOT TO EXCEED \$29.5 MILLION AND TAKING OTHER ACTIONS IN CONNECTION THEREWITH

WHEREAS, from time to time the City of San Diego [City] has acquired equipment for the purposes of providing public services; and

WHEREAS, on January 9, 2007 the City issued a Request for Proposals to, among other purposes, solicit financing proposals for the implementation of the Enterprise Resource Planning System Core Project [ERP System]; and

WHEREAS, IBM Credit LLC, [IBM] submitted a bid expressing interest in financing all components of the ERP System and City staff has determined that the terms of the bid for financing the ERP System is at a cost-effective rate to the City; and

WHEREAS, the total acquisition cost of the ERP System is estimated to be \$36.5 million and the City has determined to cash fund \$7 million of the total acquisition cost and finance \$29.5 million; and

WHEREAS, the City has determined to contribute \$3.5 million of the \$7 million by transferring \$3.5 million from the City's A-List Fund (50066) to the ERP Fund (50071); and

WHEREAS, the financed portion of the ERP System will be in an amount not to exceed \$29.5 million and the City has determined to acquire the ERP system though a lease-purchase arrangement with IBM; NOW THEREFORE

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 2. That the Auditor and Comptroller is authorized and directed to establish an ERP Fund (50071) and to transfer up to \$3.5 million from the A-List Fund (50066) to the ERP Fund.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, since a written copy was made available to the City Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
