

ORDINANCE NUMBER O- 19621 (NEW SERIES)

DATE OF FINAL PASSAGE MAY 30 2007

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his representative is authorized to execute, for and on behalf of the City of San Diego, the Second Amendment to Agreement between the City of San Diego and the San Diego Community College District [SDCCD] to reimburse the SDCCD for the construction of three parking areas to be constructed by the SDCCD as part of the Hourglass Field House – Parking Areas, a joint use project in the Mira Mesa Community.

Section 2. Stating for the record that this is not a Project, and is therefore not subject to CEQA pursuant to State CEQA Guidelines section 15060(c)(3).

Section 3. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage. The Second Amendment to Agreement with San Diego Community College District is on file in the Office of the City Clerk as Document No. 00-19621.
