DATE OF FINAL PASSAGE JUN 27 2007

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, DESCRIBING THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO'S PROGRAM TO ACQUIRE PROPERTY WITHIN THE GATEWAY CENTER WEST REDEVELOPMENT PROJECT AREA BY EMINENT DOMAIN.

WHEREAS, pursuant to Ordinance Number 0-11950 (New Series), adopted on November 17, 1976, the Council of the City of San Diego ("City") adopted a final redevelopment plan for the Gateway Center West Redevelopment Project, formerly known as Dells/Imperial Redevelopment Project (the "Redevelopment Plan"); and

WHEREAS, in accordance with California Health and Safety Code Section 33342.7(a), a legislative body that adopted a final redevelopment plan before January 1, 2007, shall adopt an ordinance on or before July 1, 2007, that contains a description of the agency's program to acquire real property by eminent domain; and

WHEREAS, Section 410 of the Redevelopment Plan, entitled Acquisition of Property, authorizes the use of the power of eminent domain within the Gateway Center West Redevelopment Project Area by the Redevelopment Agency of the City of San Diego ("Agency"); NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. The City Council hereby finds and determines that all of the foregoing recitals are true and correct.

Section 2. In accordance with California Health and Safety Code Section 33342.7(a), the Agency's program for exercise of eminent domain powers within the Gateway Center West Redevelopment Project Area (the "Program") is as follows:

A. The following provisions described in Paragraphs 410.1, 410.2 and 410.9 of Section 410 of the Redevelopment Plan, entitled Acquisition of Property:

[T]he Agency may acquire, but is not required to acquire, all real property located in the Project, by gift, devise, exchange, purchase, eminent domain, or any other lawful method.

It is in the public interest and is necessary, in order to eliminate the conditions requiring redevelopment and in order to execute the Plan, for the power of eminent domain to be employed by the Agency to acquire real property in the Project.

The time limit for commencing eminent domain proceedings for the Project is six years.

B. Such limitations may be extended only by amendment of the Plan in the manner required by law.

Section 3. The Program may only be changed by an amendment to the Redevelopment Plan, pursuant to and in the manner required and to the extent permitted by law. The power of eminent domain for the Gateway Center West Redevelopment Project Area has expired and is not currently available.

Section 4. The City Clerk is hereby ordered and directed to certify the passage of this Ordinance and to cause the same to be published in a newspaper of general circulation, published and circulated in the City of San Diego.

Section 5. If any part of this Ordinance is held to be invalid for any reason, such decision shall not affect the validity of the remaining portion of this Ordinance, and the City


Council hereby declares that it would have passed the remainder of this Ordinance if such invalid portion thereof had been deleted.

Section 6. A full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 7. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.

Section 8. That this activity is not a "project" and is therefore exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15060(c)(3).
