AN ORDINANCE OF THE CITY COUNCIL AUTHORIZING TWO-HOUR METERED PARKING ON THE 3800 BLOCK OF VERMONT STREET BETWEEN UNIVERSITY AVENUE AND THE ALLEY SOUTH OF UNIVERSITY AVENUE.

WHEREAS, the 3800 block of Vermont Street is a two-lane 51-foot wide street with parallel parking permitted on both sides of the street. Currently, two parking meters exist on both sides of Vermont Street just south of University Avenue and the remaining curb space is unregulated. In order to increase turnover and available parking, the business owners on 3875 and 3877 Vermont Street and 1201 University Avenue whose frontage is on Vermont Street have signed a petition requesting the proposed two-hour metered parking zone; and

WHEREAS, this action will authorize the establishment of a two-hour time limit metered parking zone to be effective everyday between 8:00 AM and 6:00 PM, Sundays and certain holidays excepted, on the east side of Vermont Street between University Avenue and the Alley south of University Avenue; and

WHEREAS, the City Transportation Engineering Division of the Engineering & Capital Projects Department reviewed the petition and determined, using accepted traffic engineering principles, that metered parking can be installed with an adequate margin of safety; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the establishment of a two-hour parking zone on the east side of Vermont Street between University Avenue and the Alley south of University Avenue is authorized.

Section 2. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
