AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING ANGLE PARKING ON 15<sup>TH</sup> STREET BETWEEN BROADWAY AND "E" STREET.

WHEREAS, the City Transportation Engineering Division of the Engineering and Capital Projects Department has reviewed the petition to request angle parking on 15<sup>th</sup> Street Between Broadway and "E" Street, and using accepted traffic engineering principles, determined that additional angle parking can be installed with an adequate margin of safety; NOW THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That pursuant to the authority conferred by and in accordance with the provisions of California Vehicle Code section 22503 and the San Diego Municipal Code section 86.03, the creation of an angle parking zone on 15<sup>TH</sup> Street between Broadway and "E" Street, is hereby authorized.

Section 2. That the installation of the necessary signs and markings is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.

Section 3. That the expenditure of \$3,615 for the installation of angle parking on 15<sup>th</sup> Street between Broadway and "E" Street is authorized, solely and exclusively for this Project, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds are, or will be, on deposit with the City Treasurer.

Section 5. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 6. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
