CALIFORNIA IDENTIFICATION (CAL-ID) AGREEMENT
WITH SAN DIEGO'S SHERIFF'S DEPARTMENT

WHEREAS, the County of San Diego, Sheriff's Department, is the proprietary agency for the local branch of the statewide Cal-ID fingerprint, palm print, and photo system; and

WHEREAS, the City of San Diego is a user of the Cal-ID System; and

WHEREAS, this action authorizes the City to continue its partnership with the County through June 30, 2010; and

WHEREAS, every city in the county pays a proportionate share of costs necessary to maintain the system; and

WHEREAS, the 2005 and 2006 cost for the City is \$195,017 and yearly hereafter the City will continue to pay its proportional share; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his representative is authorized and empowered to enter into and sign the attached Agreement.

BE IT FURTHER RESOLVED that the City Auditor and Comptroller be and hereby are authorized and empowered, to accept, appropriate and expend \$195,017 for FY 2005 and 2006, and the proportional share amount billed by San Diego Sheriff's Department in subsequent years, for the life of the agreement.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the Chief of Police is hereby authorized and empowered, to administer and operate this program.
