BE IT FURTHER RESOLVED, that the Mayor or is designee is hereby authorized to execute options for up to three one-year periods, provided that the Auditor and Comptroller first certify that funds for said expenditure are appropriated and unexhausted.

BE IT FURTHER RESOLVED, that the Čity Council finds that this activity is excluded from the definition of project pursuant to CEQA Guidelines section 15378(b)(2) and therefore is exempt from CEQA pursuant to the State Guidelines section 15060(c)(3).
