WHEREAS, urban runoff originating within or flowing through the City of San Diego is regulated by San Diego Regional Water Quality Control Board Order No. 2001-01 [Municipal Storm Water Permit];

WHEREAS, the City of San Diego one of 18 jurisdictions jointly responsible for implementing the Municipal Storm Water Permit, including the requirement for educational activities;

WHEREAS, the City of San Diego has, since 1999, successfully conducted the "Think Blue" educational campaign as part of City's obligation to conduct the educational activities required by the Municipal Storm Water Permit;

WHEREAS, the production and distribution of public service announcements regarding the deleterious effects of urban runoff qualifies as an educational activity for the purposes of the Municipal Storm Water Permit;

AND WHEREAS, the City of San Diego issued and officially advertised a Request for Proposal soliciting proposal from production companies, and American Dream Cinema and FourSquare Productions were selected by the interview panel to produce public service announcements;

BE IT RESOLVED, that the Mayor, or designee, is hereby authorized to execute a contract with FourSquare Productions, on file with the City Clerk as Document No.

RR-302278 to produce one (1) Public Service Announcement (PSA), and to edit closing images of previously produced PSAs for the Think Blue education and outreach campaign in the amount not to exceed \$56,000.

BE IT FURTHER RESOLVED, that the Mayor, or designee, is hereby authorized to execute a contract with American Dream Cinema, on file with the City Clerk as Document No. RR-302278 to produce two (2) Public Service Announcements (PSAs), and to edit closing images of previously produced PSAs for the Think Blue education and outreach campaign in the amount not to exceed \$107,000.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend an amount not to exceed \$56,000 from the Metropolitan Wastewater Department, Storm Water Pollution Prevention Program, General Fund 100 to provide funds for the contract with FourSquare Productions to produce one (1) Public Service Announcement (PSA), and to edit closing images of previously produced PSAs for the Think Blue education and outreach campaign.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend an amount not to exceed \$107,000 from the Metropolitan Wastewater Department, Storm Water Pollution Prevention Program, General Fund 100 to provide funds for the contract with American Dream Cinema to produce two (2) Public Service Announcement (PSAs), and to edit closing images of previously produced PSAs for the Think Blue education and outreach campaign.

BE IT FURTHER RESOLVED, that the Council of the City of San Diego finds that this activity is not a project because this action will not have a direct, or reasonably foreseeable indirect physical change in the environment and is therefore not subject to from the California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines Section 15060(c)(2).
