A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO RATIFYING THE ELECTIONS RESULTS OF FEBRUARY 13, 2007 FOR THE NORTH PARK REDEVELOPMENT PROJECT AREA COMMITTEE.

WHEREAS, on October 16, 1990, the City Council of the City of San Diego [Council], by Resolution No. R-276720, adopted the formation procedures for the North Park Redevelopment Project Area Committee [PAC]; and

WHEREAS, on December 8, 2003, the Council, by Resolution No. R-298703, adopted amendments to the formation procedures for the North Park Redevelopment PAC [Procedures]; and

WHEREAS, on December 15, 2006, the Council, by Resolution No. R-302181, approved a one year extension of the North Park Redevelopment PAC and directed the Redevelopment Agency staff to notice and conduct the annual PAC election for 2007; and

WHEREAS, after notice and in accordance with the Procedures, the North Park PAC Bylaws adopted on September 9, 2003 and applicable law, the annual PAC election was duly conducted by Agency staff on February 13, 2007; and

WHEREAS, a representative from the City Clerk's Office attended the election to ensure its validity and provide official verification of the tallying of ballots; and

WHEREAS, the newly elected members of the PAC have submitted to the City Council information establishing the qualifications and eligibility of each member relative to district, category or organization as appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. That the North Park Redevelopment Project Area Committee consisting of persons named on Exhibit "A", attached hereto and incorporated herein by this reference, as the list of Project Area Committee [PAC] members receiving the highest number of votes, including those members noted by the City Clerk's verification of the election results of February 13, 2007, is approved as constituting a representative PAC.

2. That the Council finds the election results of February 13, 2007 are valid and binding in accordance with the Procedures adopted by Resolution No. 298703.

3. That this activity is not a "project" and is therefore not subject to the California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines Section 15060(c)(3).
