A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING FIRST AMENDMENT TO THE CONSULTING AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND PAUL PLEVIN SULLIVAN & CONNAUGHTON, LLP

WHEREAS, the City of San Diego [City] entered into a Consulting Agreement (RR-301296) pursuant to resolution number R-301296, adopted on March 24, 2006, with the law firm Paul, Plevin, Sullivan & Connaughton, LLP [Firm] in an amount not to exceed \$250,000, for consulting services in connection with the 2006 Meet and Confer process with the City's five recognized employee organizations [Agreement]; and

WHEREAS, the term of the Agreement expired June 30, 2006; and


WHEREAS, the City has need of the Firm's services with regard to consulting services pertaining to the 2007 Meet and Confer process; NOW THEREFORE,

BE IT RESOLVED by the Council of the City of San Diego, that the Council approves the First Amendment to the Agreement on file in the office of the City Clerk as Document No. RR- 302487.

BE IT FURTHER RESOLVED, that the Chief Financial Officer, or designee, is authorized and directed to execute, for and on behalf of the City, the First Amendment to the Agreement for an additional amount not to exceed \$250,000, for a total contract amount not to exceed \$500,000.

BE IT FURTHER RESOLVED, that the Council approves a Citywide cost allocation, based on full-time employees, to pay for the consulting services under the terms and conditions set forth in the Agreement and the First Amendment to the Agreement pertaining to these expenditures.
