

RESOLUTION NUMBER R-302500

DATE OF FINAL PASSAGE APR 19 2007

WHEREAS, section 41.1 of the Charter of the City of San Diego established the Salary Setting Commission and set forth therein the requirement that said Commission shall recommend to the Council the enactment of an ordinance establishing salaries for the Mayor and Council as provided by the Charter; and

WHEREAS, section 12.1 pertaining to Council member salaries and section 24.1 pertaining to the Mayor's salary require that said Commission's recommendation be presented on or before February 15 of every even year, said salaries to be effective the following July 1 for a two-year period; and

WHEREAS, during Fiscal Year 2006, the Commission conducted extensive research and held a series of public hearings to determine and ascertain facts sufficient to establish salary levels for recommendation to the Mayor and Council for adoption by ordinance as required by the Charter; and

WHEREAS, the Commission, pursuant to the mandate of the Charter, presented its recommendations in a letter dated January 30, 2006, (attached hereto as Attachment A) to the Mayor and Council; and

WHEREAS, the Commission recommended no increase in annual compensation for the Mayor and City Council members, effective July 1, 2006, and an approximate 25 percent increase established and incorporated in the Fiscal Year 2008 Salary Ordinance; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Attorney is and he is hereby directed, pursuant to section 41.1 of the Charter, to incorporate the following amounts in the annual salary ordinance for Fiscal Year 2008 to be effective July 1, 2007, pursuant to the City Council's action on April 9, 2007, to reject the Salary Setting Commission's recommendation for an approximate 25 percent increase effective July 1, 2007:

Mayor \$100,464

Councilmember \$ 75,386

BE IT FURTHER RESOLVED, that the subject of the setting of salaries for the Mayor and Councilmembers is referred to the Council Rules Committee and the 2007 Charter Review Committee.
