WHEREAS, the San Diego Floral Association was one of the most influential groups involved in determining the future ambiance of San Diego; in 1907, most of San Diego resembled the sagebrush-covered areas now seen along Florida canyon and homes were surrounded with bare dirt and a few struggling plants; and

WHEREAS, the San Diego Floral Association held their first flower show in 1910 at the U.S. Grant Hotel; and

WHEREAS, during preparation for the 1915 Exposition, ladies of the Floral Association served on a City-sponsored project to plant the parkways throughout the City; and

WHEREAS, the San Diego Floral Association lobbied City Council to encourage trash

pickup be free and unlimited in amount; an ordinance that remains in effect today; and

WHEREAS, the San Diego Floral Association provides many services to all County

residents including access to one of the County's largest horticultural libraries, scholarships for

students studying in the field, design and craft workshops in the floral arts, and educational

meetings and exhibits open to the public throughout each year; and

WHEREAS, since 1909, the San Diego Floral Association has published California

Garden Magazine, one of the oldest continually-published horticultural magazines in the United

States; and

WHEREAS, since 1972, the San Diego Floral Association has participated in the park-

wide holiday program known as "December Nights" in Balboa Park; NOW, THEREFORE,

BE IT RESOLVED, by the Mayor and Council of the City of San Diego, that this

Council, for and on behalf of the people of San Diego, does hereby congratulate the San Diego

Floral Association for its passionate commitment to the education and guidance of San Diego's

horticultural issues over the past 100 years.
