A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REGARDING THE REPROGRAMMING OF CDBG FUNDS.

WHEREAS, on May 8, 2006, the City Council adopted Resolution No. R-301424, in which the City Council authorized the City Auditor and Comptroller to accept CDBG funds in the amount of \$15,506,862 from the U.S. Department of Housing and Urban Development for the City's FY 2007 CDBG Program; and

WHEREAS, in Resolution No. R-301424, the City Council also approved the funding allocations and recommendations for the City's FY 2007 CDBG Program, as set forth in Report to the City Council No. 06-047, a copy of which is on file with the Office of the City Clerk as Document No. RR-301424, as modified by memoranda from Council District 2, Council District 4, and Council District 7, a copy of each memorandum is on file with the Office of the City Clerk as Document Nos. RR-301424-1, RR-301424-2, and RR-301424-3, respectively; and

WHEREAS, on October 24, 2006, the City Council adopted Resolution No. R-302033, in which the City Council approved the reprogramming of CDBG funds for Council Districts 1, 3, 4, 5, 6, 7, 8, and Citywide, as set forth in the Executive Summary Sheet filed with that action;

WHEREAS, on February 6, 2007, the City Council adopted Resolution No. R-302336, in which the City Council approved the reprogramming of CDBG funds for Council Districts 1, 2, 3, 6, and 8, as set forth in Report to the City Council No. 07-026, a copy of which is on file with the Office of the City Clerk as Document No. RR-302336;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the reprogramming of CDBG funds for Council Districts 1, 3, 4, 6, 7, and 8, as set forth in Report to the City Council No. 07-063, a copy of which is on file with the Office of the City Clerk as Document No. R-302553, is hereby approved, contingent upon certification of funds availability by the City Auditor and Comptroller.

2. That the Mayor or his designee is authorized to negotiate and execute agreements with the CDBG-funded projects approved for funding, contingent upon certification of funds availability by the City Auditor and Comptroller.

3. That the City Auditor and Comptroller is authorized to appropriate and expend the CDBG funds for the CDBG-funded projects approved for funding.
