BE IT RESOLVED, by the Council of the City of San Diego, in accordance with the settlement agreement related to preferential tee times at Torrey Pines Golf Course negotiated between Plaintiffs, the Hilton Hotel which adjoins the Torrey Pines Golf Course and the City of San Diego, that the Mayor or his designee is hereby authorized and empowered to pay the total sum of Sixty-Five Thousand Dollars (\$65,000.00) as part of the settlement of each and every claim against the City of San Diego, its agents and employees, in San Diego Superior Court Case No. GIC 849647, entitled *Howard DeYoung, et al. v. City of San Diego*.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to issue one check in the amount of Sixty-Five Thousand Dollars (\$65,000.00) made payable to Torrey Pines Mens Golf Club as part of the settlement of the lawsuit and of all claims.

BE IT FURTHER RESOLVED, that said funds are to be payable from the Public

Liability Fund 81140.
