BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Fiscal Year 2007 Capital Improvement Program Budget is amended by adding CIP No. 12-159.0, Watershed Water Quality Improvements.
- 2. That the Fiscal Year 2007 Capital Improvements Program Budget for Fund 630221 is amended by increasing the budget amount by \$2,075,000.
- 3. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$2,075,000 from Fund 100, General Services, Storm Water Pollution Prevention Division Operating Fund to Fund 630221, Contributions from 100 Fund.
- 4. That the appropriation and expenditure of an amount not to exceed \$2,075,000 from CIP No. 12-159.0, Fund 630221, is authorized solely and exclusively for the purpose of providing funds for Watershed Water Quality Improvements Phase 1 project.
- 5. That the above expenditure is contingent on appropriate approval and award of one or more contracts for performance of the Watershed Water Quality Improvements- Phase 1 project, if said project will not be performed by City forces, and provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure under such contracts are, or will be, on deposit in the City Treasury.
- 6. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that this activity is not a "project" and is therefore exempt from CEQA Guidelines Section 15060(c)(2).
