A RESOLUTION OF THE CITY OF SAN DIEGO AUTHORIZING SETTLEMENT OF THE PROPERTY DAMAGE MATTER CLAIM OF BRUNO ETCHEPARE V. CITY OF SAN DIEGO IN THE SUM OF \$100,000

WHEREAS on January 6, 2006, Bruno Etchepare filed suit against the City of San Diego [City] alleging property damage arising from a failed storm drain. Plaintiff brought suit in the San Diego Superior Court. The suit is styled *Bruno Etchepare v. City of San Diego*, Case No GIC 859369 [Litigation]; and

WHEREAS the City in closed session on March 19, 2007, authorized settlement of the Litigation for an amount consistent with the amounts set forth below, NOW THEREFORE,

BE IT RESOLVED by the Council of the City of San Diego that the Council authorizes:

1. The Mayor to pay the sum of \$100,000 in settlement of each and every claim against the City, its agents and employees, resulting from the Property Damage Claim of Bruno Etchepare.

- The City Auditor and Comptroller to issue a check in the amount of \$100,000 2. payable to Bruno Etchepare and his attorney of record, Peter M. Polischuk, Esq.
