WHEREAS, Michael Murphy grew up in Southern California, graduated from California State University, at Long Beach, and is a Certified Public Accountant [CPA]; and

WHEREAS, Michael Murphy is President and Chief Executive Officer of Sharp HealthCare where he oversees a workforce of nearly 14,000 employees, 2,600 affiliated physicians, and 2,000 volunteers; and

WHEREAS, Sharp HealthCare provides care and service in a fully integrated non-profit system that includes four acute care hospitals, three specialty hospitals, three affiliated medical groups, five urgent care centers, four skilled nursing facilities, home health, hospice, state-of-the-art outpatient facilities, and a health plan; and

WHEREAS, Michael Murphy's career in health care spans more than 20 years; before joining Sharp, he worked in the public accounting industry specializing in health care, including as a partner with Deloitte and Touche, an international accounting and consulting firm; and

WHEREAS, Michael Murphy's career at Sharp began in 1991 as Chief Financial Officer [CFO] of Grossmont Hospital before moving to Sharp's system-wide role of Vice President of Financial Accounting and Reporting; and

WHEREAS, prior to his appointment as President and Chief Executive Officer [CEO], Michael Murphy served as Senior Vice President of Business Development and Legal Affairs where he directed major business transactions and implemented business development opportunities throughout the Sharp system; and

WHEREAS, Michael Murphy was appointed to his current position in June of 1996 by a 29-member Board of Directors; and


