BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That in accordance with the Annual Appropriation Ordinance, the City Auditor and Comptroller is authorized and directed to amend the Fiscal Year 2007 Capital Improvement Program budget to add CIP No. 29-948.0, Kearny Mesa Community Park-Sidewalk Improvements.
- 2. That the Fiscal Year 2007 Capital Improvements Program Budget for CIP 29-948.0, Kearny Mesa Community Park-Sidewalk Improvements is amended by increasing the budget amount by \$70,000.00.
- 3. That the City Auditor and Comptroller is authorized to appropriate and expend an amount not to exceed \$70,000.00 from CIP 29-948.0 Kearny Mesa Community Park Sidewalk Improvements, Fund 18542, Community Development Block Grant Fund 2007, for the design and construction of ADA sidewalk improvements at the Kearny Mesa Community Park, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditures are, or will be, on deposit with the City Treasurer.
- 4. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
- 5. That this activity is exempt by California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines Section 15301, Existing Facilities.
