WHEREAS, Sharren L. Carr graduated from San Diego State University in 1976 with a Bachelor of Arts degree in Public Administration; and

WHEREAS, Sharren L. Carr holds certifications from the American Institute of Certified Planners, the International Code Council; and

WHEREAS, Sharren L. Carr co-authored "The Importance of Partnerships in Providing Effective Code Enforcement – A Team Approach" for International Municipal Lawyers Association and authored the Code Enforcement Procedures Manual for the City of San Diego; and

WHEREAS, from 1985 to 1994 Sharren L. Carr was a Zoning Administrator where she administered, enforced and interpreted Planning and Zoning regulations; a Hearing Officer for variances and special permits; and staff for the Board of Zoning Appeals and City Council where she facilitated discussions with a twenty-four-member Professional and Citizen Committee, created newsletters to clarify regulations, produced a Code Enforcement Procedure Manual, an Administrative Citations Manual and a Volunteer Manual; and

WHEREAS, in 1987, Sharren L. Carr developed and implemented the first Citizen Volunteer Program in the Tierrasanta community to assist city staff in obtaining compliance with minor code violations, which now is comprised of twenty-seven communities throughout San Diego; and

WHEREAS, from 1994 to 2005 Sharren L. Carr was a Program Manager for Neighborhood Services where she was primarily responsible for code enforcement of Planning and Zoning regulations, supervised Building Inspectors and was Residential Team Leader for the Zoning code update; and

WHEREAS, in 2005 Sharren L. Carr was promoted to the position of Deputy Director for the Neighborhood Code Compliance Division of the Development Services Department where she was responsible for code enforcement of Planning, Zoning and Building code regulations; and

WHEREAS, Sharren L. Carr has been instrumental in implementing proactive code enforcement throughout the City of San Diego; and

WHEREAS, Sharren L. Carr has developed an effective partnership with the Mayor and City Council Offices to create favorable situations for San Diego residents; and

WHEREAS, Sharren L. Carr is retiring after being employed with the City of San Diego for the past 37 years; NOW, THEREFORE,

BE IT RESOLVED, by the Mayor and Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby commend Sharren L. Carr for her passionate commitment to neighborhood code enforcement and thanks her for her dedication to the City of San Diego.
