BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to the Cooperative Agreement with the City of Carlsbad, RR-30067-2 dated June 27, 2005, for fund transfer and completion of the Clairemont Mesa/SR-163 Interchange Project ("Project") under the terms and conditions set forth in this First Amendment to the Cooperative Agreement with the City of Carlsbad, on file in the office of the City Clerk as Document No. RR 302684.
- 2. That the Fiscal Year 2007 Capital Improvements Program Budget is amended by decreasing CIP 52-392.0, Carroll Canyon Road Extension Project, special interest bearing Fund 38996 by \$2,300,000 and increasing CIP 52-745.0, Clairemont Mesa Boulevard/SR-163 Interchange Project, Fund 38996 by \$2,300,000.
- 3. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$2,300,000 from CIP 52-392.0, Carroll Canyon Road Extension Project, special interest bearing Fund 38996 to CIP 52-745.0, Clairemont Mesa Boulevard/SR-163 Interchange Project, Fund 38996.
- 4. That the expenditure of an additional amount not to exceed \$2,300,000 from CIP 52-745.0, Clairemont Mesa Boulevard/SR-163 Interchange Project, Fund 38996, is authorized, solely and exclusively for the purpose of reimbursing the State of California for the construction of the Project and other Project related costs, contingent upon the Auditor and Comptroller first

furnishing one or more certificates certifying that the funds are or will be on deposit with the City Treasurer.

5. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that this activity is not a "project" and is therefore exempt from CEQA pursuant to State CEQA Guidelines, Section 15060(c)(3).
