WHEREAS, in the Closed Session Meeting of April 17, 2007, in the matter of Robert Cervantes v. City of San Diego (San Diego Superior Court Case No. GIC 870718), the City Council voted 5 to 0 to approve the settlement. The motion was made by Council President Pro Tem Young with a second by Council President Peters. Councilmembers Faulconer, Madaffer and Maienschein were absent.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of San Diego that the Council authorizes:

- 1. The sum of \$100,000.00 to be paid from the Public Liability Fund (81140) in settlement of each and every claim against the City, its agents and employees, arising from the Litigation.
- 2. The City Auditor and Comptroller to issue a check in the amount of \$100,000.00 payable to Robert Reynolds Attorney Client Trust Account.
