WHEREAS, Barbara’s knowledge and proficiency in her professions was recognized in the City with the distinction of the Citywide Customer Service Award in 2002; and


WHEREAS, in 2002 Barbara's experience was further utilized as she became a member of the Mail System Management Association, whose goal is to increase efficiency and professionalism; and
