BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Fiscal Year 2007 Capital Improvements Program Budget for CIP No. 11-302.0, Ransom and Darwin Storm Drain Replacement Project, is amended by increasing the budget amount by \$30,000.

2. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$30,000 from CIP No. 13-005.0, Emergency Drainage Projects, to CIP No. 11-302.0, Ransom and Darwin Storm Drain Replacement Project, within Fund No. 30300, TransNet.

3. That the appropriation and expenditure of an amount not to exceed \$30,000 from CIP No. 11-302.0, is authorized solely and exclusively for the purpose of providing funds for Ransom and Darwin Storm Drain Replacement Project, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditures are, or will be, on deposit with the City Treasurer.

4. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that this activity is not a "project" and is therefore not subject to CEQA pursuant to State CEQA Guidelines Section 15060(c)(3).
