A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING ALLOCATION OF FUNDS FOR THE NORMAL STREET MEDIAN IMPROVEMENTS PROJECT.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Fiscal Year 2007 Capital Improvement Program Budget is amended by adding CIP No. 52-769.0, Normal Street Median Improvements [Project].
- 2. That the Auditor and Comptroller is Authorized to increase the Fiscal Year 2007
 Capital Improvements Program Budget in CIP No. 52-769.0, Normal Street Median
 Improvements, by \$228,250 of which \$104,000 is in Fund No. 79512, Development Impact Fees
 and \$124,250 is in Fund No. 70303, Community Parking District Fund (Uptown CDP),
- 3. That the appropriation and expenditure of an amount not to exceed \$228,250 from CIP No. 52-769.0, is authorized solely and exclusively for the purpose of engineering and construction funds for the Project, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditures are, or will be, on deposit with the City Treasurer.
- 4. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, from CIP No. 52-769.0, Normal Street Median Improvements, to the appropriate reserves.

BE IT FURTHER RESOLVED, that this activity is not a "project" and is therefore exempt from CEQA pursuant to State CEQA Guidelines Section 15060(c)(3). Further environmental analysis will be required prior to authorization of construction contract.
