A RESOLUTION AUTHORIZING CONTRACT AWARD AND EXECUTION; EXPENDITURE OF FUNDS FOR CONTRACT PURPOSES; AND TAKING RELATED ACTIONS.

[CDM] was selected as the most qualified firm to be awarded a Consulting Agreement by the City for the San Pasqual Groundwater Conjunctive Use Study Project [Project]; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor or his designee, is hereby authorized and empowered to execute, for and on behalf of said City, a Consulting Agreement with CDM, which is on file in the office of the City Clerk as Document No. RR 302745 for consulting services for the Project in an amount not to exceed \$950,000.00; and
- 2. That the expenditure of an amount not to exceed \$950,000.00 in Water Fund 41500, Misc 4222 is hereby authorized, solely and exclusively for the purpose of providing funds for the above Consulting Agreement and Project related costs, provided that the City Auditor and

Comptroller first furnishes one or more certificates certifying that the funds are, or will be, on deposit with the City Treasurer; and

- 4. That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves; and
- 5. That this activity is categorically exempt from the California Environmental Quality Act [CEQA] pursuant to CEQA Guidelines section 15306.
