A RESOLUTION OF THE CITY COUNCIL AUTHORIZING CHANGE ORDER NO. 1 WITH SRM CONTRACTING & PAVING AND AUTHORIZING THE EXPENDITURE OF \$1,897,005 IN CONNECTION WITH THE PROJECT FOR ASPHALT OVERLAY, GROUP II, FISCAL YEAR 2007.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That Change Order No. 1, dated May 7, 2007, on file in the office of the City Clerk as Document No. RR-302801, issued in connection with the contract between Superior Ready Mix, dba SRM Contracting & Paving for street repairs, said contract having been filed in the office of the City Clerk as Document No. RR-302357, is approved, together with the changes set forth therein, amounting to a net increase in the contract price of \$1,868,995.
- 2. That the expenditure of an amount not to exceed \$1,897,005 from Fund No. 30300, CIP 59-001.0, Annual Allocation-Resurfacing City Streets, is authorized, solely and exclusively to provide funds for the above Change Order No. 1 and related costs.
- 3. That the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to appropriate reserves on advice from the administering department.
- 4. That the above activity is exempt from the California Environmental Quality Act pursuant to CEQA Guideline section 15301(c) as the repair or maintenance of existing highways and streets.
