WHEREAS, on April 4, 2005, the City Council adopted Resolution Number R-300275, authorizing the Chief of Police, on behalf of the City Manager, to apply for, accept, and expend funds for a grant from the State of California Office of Traffic Safety, titled, "Seat Belt Compliance Campaign," in the amount of approximately \$86,207.00;

WHEREAS, in Resolution Number R-300275, the City Council authorized the Chief of Police to accept, expend, and administer any amendments, extensions, renewals, or future funding of the "Seat Belt Compliance Campaign" program for a period of up to five years, provided funding is made available by the State of California;

WHEREAS, as part of the "Seat Belt Compliance Campaign" program, UC Berkeley will now administer and coordinate the "Click It or Ticket Program" for the California Office of Traffic Safety;

WHEREAS, the San Diego Police Department wishes to apply for, accept and expend grant funds for a program entitled "Click It or Ticket" (CIOT) as part of the National Seat Belt Compliance Campaign from the California Office of Traffic Safety administered through UC Berkeley; in the amount of approximately \$85,818.60; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief of Police be, and is hereby authorized and empowered, for and on behalf of the City of San Diego, to submit an application for, accept, expend and manage the grant funds and program for the purposes stated above.

BE IT FURTHER RESOLVED that this authority includes the execution of all aspects of fund and program operation, including any amendments, extensions, augmentations, or renewals from the State of California for identical or closely related purposes; and to certify that the City will comply with all applicable statutory or regulatory requirements.

BE IT FURTHER RESOLVED that this authorization shall be valid for a period of up to five years, provided funding for this purpose is made available by the State of California.

BE IT FURTHER RESOLVED that any resources received hereunder shall be used to supplement and not to supplant expenditures controlled by this body.
