WHEREAS, the City and Ms. Williams now desire to resolve and settle all claims relating to the property damage; and

WHEREAS, the City in closed session on June 12, 2007, authorized settlement of the claims for an amount consistent with the amounts set forth below, NOW THEREFORE,

BE IT RESOLVED by the Council of the City of San Diego that the Council authorizes:

- 1. The sum of \$54,609.71 in settlement of each and every claim against the City, its agents and employees, resulting from the Property Damage Claim of Mary Williams.
- 2. That the expenditure of an amount not to exceed \$54,609.71 from the Metropolitan Waste Water Department, Fund No. 41506, is hereby authorized, and The City Auditor and Comptroller are to issue two separate checks, first check made payable to Mary Williams in the amount of \$50,532.21; and second check made payable to Service Master in the amount of \$4,077.50
