WHEREAS, San Diego Municipal Code section 125.1010 (c)(3) provides for the summary abandonment of easements by City Council resolution where the easement to be vacated has been superceded by relocation and there are no other public facilities located within the easement; and

WHEREAS, the affected property owners have requested the vacation of the unnecessary water easement in portions of Lots, 7, 8, 13, 17, 18 & "A" of Map No. 14283, Lots 2, 3, 13 and 17 of Map No. 14570 and the SE ¼, SE ¼, NW ¼, Sec. 22, T14S, R3W SBBM as depicted on Engineering Drawing No. 20273-B to unencumber their property; and

WHEREAS, City staff has requested this vacation as this water easement is no longer necessary because the water lines originally planned for this easement have been constructed in the dedicated public right-of-way; and

WHEREAS, this action is exempt from environmental review pursuant to state California Environmental Quality Act [CEQA] Guidelines section 15060(C)(3) on the basis that this is not a project for the purposes of CEQA; and

WHEREAS, under Charter section 280(a)(2) this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body, a public hearing was required by law implicating due process rights of individuals affected by the decision, and the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego the Council makes the following findings:

SDMC § 125.1040 FINDINGS FOR A PUBLIC SERVICE EASEMENT ABANDONMENT

- (a) There is no present or prospective public use for the easement, either for the facility or purpose for which it was originally acquired or for any other public use of a like nature that can be anticipated;
- (b) The public will benefit from the action through improved utilization of the land made available by the abandonment;
 - (c) The abandonment is consistent with any applicable land use plan; and
- (d) The public facility or purpose for which the easement was originally acquired will not be detrimentally affected by the abandonment or the purpose for which the easement was acquired no longer exists.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, as follows:

1. That the water easement located within portions of Lots 7, 8, 13, 17, 18 & "A" of Map No. 14283, and Lots 2, 3, 13 & 17 of Map No. 14570, and the SE 14, SE ¼, NW ¼, Sec. 22, T14S, R3W, SBBM, as more particularly described in the legal description marked as Exhibit "A", and as shown on Drawing No. 20273-B, marked as Exhibit "B", and on file in the office of the City Clerk as Document Nos. RR- 302838-1, and RR- 302838-2, which are by this reference incorporated herein and made a part hereof, is ordered vacated.


