ADOPTING AND APPROVING AS THE COUNCIL'S RESPONSE TO THE 2006-2007 SAN DIEGO COUNTY GRAND JURY REPORT DATED MAY 10, 2007, AND TITLED "SAN DIEGO CITY REAL ESTATE ASSETS," THE RESPONSE PREPARED BY THE INDEPENDENT BUDGET ANALYST, AND AUTHORIZING AND DIRECTING THE COUNCIL PRESIDENT TO EXECUTE AND DELIVER THE COUNCIL'S RESPONSE TO THE PRESIDING JUDGE OF THE SAN DIEGO COUNTY SUPERIOR COURT NO LATER THAN AUGUST 9, 2007.

WHEREAS, on May 10, 2007, the 2006-2007 San Diego County Grand Jury [Grand Jury] filed a report [Report] titled "San Diego City Real Estate Assets;" and

WHEREAS, under California Penal Code section 933(c), within 90 days after the filing of the Report, each public agency which the Grand Jury reviewed, and about which it issued the Report, must comment to the Presiding Judge of the Superior Court on the findings and recommendations pertaining to matters under the control of the agency; and

WHEREAS, the Grand Jury requested that the City of San Diego respond to Report recommendations numbered 07-19, 07-20, 07-22; and

WHEREAS, the Grand Jury requested that the San Diego City Council respond to Report recommendation number 07-21; and

WHEREAS, the Mayor has responded to all the findings and recommendations of the Report, except recommendation number 07-21, by letter to the Presiding Judge of the San Diego County Superior Court, dated July 6, 2007; and

WHEREAS, the City's Independent Budget Analyst has proposed a City Council response to the Report; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of The City of San Diego, that the Council approves and adopts as its own the response to the 2006-2007 San Diego County Grand Jury in its report dated May 10, 2007, and titled "San Diego City Real Estate Assets," prepared by the Independent Budget Analyst [Council's Response]; and

BE IT FURTHER RESOLVED, the City Council President is authorized and directed, on behalf of The City of San Diego and the City Council, to execute and deliver the Council's Response to the Presiding Judge of the San Diego County Superior Court no later than August 9, 2007, a copy of which is filed in the Office of the City Clerk as Document No. 12850.
