RETENTION OF THOMAS LAUBE OF SANDLER LASRY
LAUBE BYER & VALDEZ, FOR LEGAL SERVICES IN DEFENSE
OF *LA JOLLA ALTA MASTER COUNCIL V. CITY OF SAN DIEGO*

WHEREAS, the City Council authorized the City Attorney to seek outside expert legal counsel to provide legal services in connection with the defense of the litigation entitled *La Jolla Alta Master Council v. City of San Diego, et al.*, San Diego Superior Court Case No. GIC822281; and

WHEREAS, after inquiring of the profession for such expertise, Thomas Laube of the law firm of Sandler Lasry Laube Byer & Valdez was determined to be one of the premiere law firms in this area of legal practice; and

WHEREAS, said firm has indicated its willingness and ability to provide such services under a retainer agreement;


WHEREAS, in the Closed Session Meeting of February 27, 2007, in the matter of *La Jolla Alta Master Council v. City of San Diego, et al.*, San Diego Superior Court Case No. GIC822281, the City Council voted 8 to 0 to authorize the extension of a retainer agreement with the law firm of Sandler Lasry Laube Byer & Valdez to provide legal services in connection with the defense of the aforementioned litigation. The motion was made by Council President Peters with a second by Councilmember Madaffer.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego, that the City Attorney be and he is hereby fully authorized to extend the retainer agreement with the law firm of Sandler Lasry Laube Byer & Valdez pursuant to the terms and conditions of that

retainer agreement, dated November 2, 2005, a copy of which is on file in the office of the City Clerk as Document No. RR- 301345, to serve as outside counsel in connection with the *La Jolla Alta* litigation.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within the Public Liability Fund the sum of \$125,000 to provide funds for the above retainer agreement with Sandler Lasry Laube Byer & Valdez, and expend said funds as requested.
